The Associação Geral de Automóvel de Macau - China will sanction the **58th** Macau Grand Prix which is the property of the “Comissão do Grande Prémio de Macau” (Macau Grand Prix Committee) and comprises (approximately) six races for different categories.

All the participating parties (ASN, Organisers, Competitors and Circuit) undertake to apply as well as observe the rules, governing the event.

Should any dispute arise, the panel of the Stewards of the meeting will be the only authority to make a decision (**ISC-Art.141**).

1) REGULATIONS

- 1.1** The final text of these Sporting and Specific Technical Regulations shall be the English version which will be used should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Sporting and Specific Technical Regulations.
- 1.2** The **MACAU GT CUP** is governed by the FIA International Sporting Code and its Appendixes (including Appendix J), the circuit General Prescriptions, and these Sporting Regulations specific for this Race and their relevant Appendixes / Bulletins.
- 1.3** Clarification, interpretation and arbitration of any rules, requirements and regulations not covered by the FIA ‘General Prescriptions’ and Specific Regulations, Sporting Code and Technical Regulations of GT Asia Series 2011 shall be decided by the Stewards of the meeting.
- 1.4** The final championship round of the GT Asia Series 2011, is integrated in the MACAU GT CUP race of the 58th Macau Grand Prix.

2) GENERAL UNDERTAKING

All drivers, competitors and officials participating in the Event undertake, on behalf of themselves, their employees and agents, to observe all the provisions as supplemented or amended of the International Sporting Code (the Code), the Technical Regulations, FIA Official Bulletins and the present Sporting Regulations.

3) GENERAL CONDITIONS

- 3.1** It is the competitor’s responsibility to ensure that all persons concerned by his entry observe all the requirements of the Code, the Technical Regulations and the Sporting Regulations. If an entrant is unable to be present in person at the Event he must nominate his representative in writing. The person having charge of an entered car during any part of an Event is responsible jointly and severally with the competitor for ensuring that the requirements are observed.
- 3.2** Competitors must ensure that their cars comply with the conditions of eligibility and safety throughout practice sessions and the race.
- 3.3** The presentation of a car for scrutineering will be deemed an implicit statement of conformity.
 - a) All persons concerned in any way with an entered car or present in any other capacity whatsoever in the paddock, pits, pit lane or track must wear an appropriate pass at all times.
 - b) The entrant shall declare that to the best of his belief his driver(s) possess(es) the standard of competence necessary for an event of the type to which the entry relates, that should his driver(s) at the time for the event be suffering from any disability whatsoever he shall declare the disability to the Stewards prior to the driver(s) driving on the track, that the vehicle entered is suitable and roadworthy for the event having regard to the track and the speed that will be reached and that he, his driver(s) and team members enter upon and use the track and its facilities entirely at his or their own risk.

4) ELIGIBLE DRIVERS AND COMPETITORS

All drivers and competitors must hold current and valid **FIA INTERNATIONAL LICENCES**, authorizations issued by their ASN(s). A driver must also be in possession of a current medical certificate of aptitude, either included on the competition license or on an attached document.

All documents must be presented at the event at the times stated in the appropriate Appendix.

5) EVENT

5.1 The Event will have the status of a RESTRICTED INTERNATIONAL Event.

5.2 The Event is restricted by invitation.

5.3 The Event shall include all practices and race.

5.4 There will be a race run over 12 laps. Each lap is 6.2kms and is run in a clockwise direction or 40 minutes (*)

(*) Race Time

If the leading driver has not achieved the defined race distance after the schedule time elapsed, the leader will be shown the chequered flag the next time he/she passes the Finish Line. In this case, notification of the last lap will be advised to competitors by the showing of a board on the Start / Finish Line

5.5 The Event will take place in Macau from 17th – 20th November 2011.

5.6 The Macau Grand Prix Committee reserves the right to postpone, abandon or cancel the Event or part thereof. In the event of abandonment, cancellation or of postponement for more than 48 hours, the Entrant/Competitor will have no right of claim against the Promoters or Macau Grand Prix Committee in respect of any prize moneys or loss of expenses that he may have incurred or may incur as a result.

6) SCHEDULE AND OFFICIALS

The Provisional list of officials is noted in the appropriate Appendix.

The Provisional Schedule for practice / qualifying sessions is noted in the appropriate Appendix.

The Race start time is noted in the appropriate Appendix.

7) INSURANCE

7.1 The promoter of the Event must procure 90 days before the event that all competitors, their personnel, sponsors, agents and drivers are covered by adequate third party insurance.

7.2 The promoter must send before the Event the FIA details of the risks covered by the insurance policy which must comply with the national laws in force.

7.3 Third party insurance arranged by the promoter shall be in addition and without prejudice to any personal insurance policy held by a competitor or any other participant in the Event. Drivers taking part in the Event are not third parties with respect to one another.

7.4 Sight of the policy must be available to the competitors on demand.

8) OFFICIALS

8.1 The following officials will be nominated by the ASN :

- three Stewards of the meeting one of which must be a national steward ;
- the Clerk of the Course.

- 8.2** The Clerk of the Course, the Stewards must be present at the Event from 10:00 on the date of initial scrutineering.
- 8.3** The Clerk of the Course must be in radio contact with the chairman of the Stewards at all times when cars are permitted to run on the track. Additionally, the Clerk of the Course must be in race control and in radio contact with all marshals' posts during these times.
- 8.4** The Clerk of the Course shall have authority in the following matters:
- a) the control of practice and the race, adherence to the timetable and, if he deems it necessary, the making of any proposal to the Stewards to modify the timetable in accordance with the Code or Sporting Regulations ;
 - b) the stopping of any car in accordance with the Code or Sporting Regulations ;
 - c) the stopping of practice or suspension of the race in accordance with the Sporting Regulations if he deems it unsafe to continue and ensuring that the correct restart procedure is carried out ;
 - d) the starting procedure ;
 - e) the use of the safety car.

9) ENTRIES

- 9.1** All entries must submit an Official Entry Form, from 15th August to 15th September 2011, Commercial Entrants will also be accepted.
- 9.2** Macau Drivers who wish to participate the 58th Macau Grand Prix " MACAU GT CUP " race, have to participate at least one of the Event's races shown in the following chart or races of an equivalent Event and with the final result as classified.

The Organiser have the right to refuse any entry should it be deemed by them to be against the best interest of the Event.

Once the entry is accepted by the organiser, the applicant shall be notified to settle the payment of the entry fee of \$ 6,000.00, from 16th September to 23rd September 2011.

Entry fee can be in Patacas or Hong Kong Dollars

Entry fee is not refundable except as qualify in **Article 5.6**

9.2 Entries will be closed on either:

Receipt of the maximum number permitted to start in any practice session or on 15th of September 2011.

A minimum of 15 entries must be received for the race to be run

Each driver is only permitted to enter in one race in Macau Grand Prix.

All multiple entries of vehicles in more than one race are prohibited

10) PASSES – TEAM IDENTIFICATION

Identification passes will be issued for each competing vehicle on the following basis:

Entrant	1 (*)
Driver	1
Mechanics	4

(*) If applied by the Commercial Entrant.

Identification will not be issued unless names and identity cards or passports numbers are provided.

Identification passes will be issued at the track office to the entrant, or his representative authorized in writing.

Identification must be properly worn. Abuse of the privileges will result in these privileges being withdrawn completely.

11) INSTRUCTIONS AND COMMUNICATIONS TO COMPETITORS

11.1 The Stewards or Clerk of the Course may give instructions to competitors by means of special circulars in accordance with the Code. These circulars will be distributed to all competitors who must acknowledge receipt.

11.2 All classifications and results of practice and the race, as well as all decisions issued by the officials, will be posted on the official notice board.

11.3 Any decision or communication concerning a particular competitor should be communicated to him forthwith in writing within 25 minutes of such decision and receipt must be acknowledged.

12) INCIDENTS

12.1 Incident means any occurrence or series of occurrences involving one or more drivers or any action by any driver, which is reported to the Stewards by the Clerk of the Course (or noted by the Stewards and referred to the Clerk of the Course for investigation) which :

- necessitated the suspension of a race under **Article 37** ;
- constituted a breach of these Sporting Regulations or the Code ;
- caused a false start by one or more cars ;
- caused an avoidable collision ;
- forced a driver off the track ;
- illegitimately prevented a legitimate overtaking manoeuvre by a driver ;
- illegitimately impeded another driver during overtaking ;
- unless it was completely clear that a driver was in breach of any of the above, any incidents involving more than one car will normally be investigated after the race.

12.2 a) It shall be at the discretion of the Stewards to decide upon a report or a request by the Clerk of the Course, if a driver or drivers involved in an incident shall be penalised.

- b) If a driver is involved in a collision or Incident (see **Article 12.1**), and his team have been informed of this by the Stewards no later than five minutes after the race has finished, he must not leave the circuit without their consent.

12.3 The Stewards may impose a 60 seconds time penalty on any driver involved in an Incident.

12.4 Any determination made or any penalty imposed pursuant to **Article 12** shall be without prejudice to the operation of Article 160 and 161 of the Code.

13) PROTESTS AND APPEALS

13.1 Protests shall be made in accordance with the Code and accompanied by a fee in cash of US\$1000 (one thousand US dollars) or its equivalent in local currency.

13.2 In case of a team to team technical protest an additional bond of US\$1000 (one thousand US dollars) or its equivalent in local currency will be lodge with the organizer and returned to the protester if the protest is upheld or paid to the protested team in the case of an invalid protest.

13.3 Appeals must be made in accordance with the International Sporting Code. Appeal fee will be in cash of US\$6000 (six thousand US Dollars) or its equivalent in local currency.

14) SANCTIONS

The Stewards may inflict the penalties specifically set out in these Sporting and Specific Technical Regulations in addition to or instead of any other penalties available to them under the Code.

15) DRIVING

15.1 The driver must drive the car alone and unaided.

15.2 The driver is not permitted to participate in any additional practice, qualifying or race within the Event.

15.3 Manoeuvres liable to hinder other drivers, such as more than one change of direction to defend a position, deliberate crowding of a car beyond the edge of the track or any other abnormal change of direction, are not permitted.

- 15.4** Drivers must use the track at all times. For the avoidance of doubt the white lines defining the track edges are considered to be part of the track but the kerbs are not.

A driver will be judged to have left the track if no part of the car remains in contact with the track.

Should a car leave the track for any reason the driver may rejoin. However, this may only be done when it is safe to do so and without gaining any advantage.

- 15.5** As soon as a car is caught by another car which is about to lap it during the race the driver must allow the faster driver past at the first available opportunity. If the driver who has been caught does not allow the faster driver past, waved blue flags will be shown to indicate that he must allow the following driver to overtake.

Any driver who is deemed to be ignoring the waved blue flags will be reported to the Stewards of the meeting.

16) RACE NUMBERS AND DRIVER'S NAME

- 16.1** Each car must carry the race number selected by the Organiser for its driver. All numbers must be in position before scrutineering. The number must be placed on the bonnet / nose of the car and on each side of the car and the Scrutineer may reject any vehicle whose numbers do not meet the specifications below.

The size of number should be 28 cm high with a stroke of 5 cm and shall be in black on a white background with at least 5 cm border to the number. In the case of a white vehicle, the background must be delineated by a continuous black line 5 cm wide.

- 16.2** Every competitor must display the name of the driver and his national flag on the bodywork or on the outside of the cockpit. These must be clearly legible.
- 16.3** The position above the start numbers must be left free for possible use by the Organiser for their sponsor's identification to a height of 12 cm. and equal in width to the number background.
- 16.4** Additional requirements relating to the start numbers may be noted in the relevant Appendix, specific Sporting Regulations or subsequently issued notices.

17) PROMOTION

- 17.1** Drivers must take part in any promotional activity requested by the organizers such as autograph sessions, prize giving, press conferences, pit road walkabouts and pre-race parades. This is in addition to **Article 31**.
- 17.2** The drivers, competitors and manufacturers give the right to the Organiser to use their name for any promotional, advertising, publicity and public relations purpose, for the promotion of the Event.
- 17.3** Use of the Organiser logo by the competitors, manufacturers and drivers or their agents or representatives is prohibited other than by prior permission in writing from the Organiser.

18) NUMBERS OF CARS PARTICIPATING

The number of cars allowed to start each race and practice is limited to 36.

19) ELIGIBLE CARS

19.1 Accepted cars must be mass-produced, series production Grand Touring cars, Sports cars and have at least 2 Seats in accordance with the dimensions defined by the manufacturer.

19.2 GT3 Class

The car should be a GT3 race series production car as per FIA homologation specification for the make as per showing below, with current FIA specification **RESTRICTOR**.

19.3 GT (M) Class

The car should be large scale series production car as per FIA homologation specification for the make.

The race cars as per list showing below or as per GT Asia Series 2011 R & R's Technical Regulations noted in the appropriate Appendix.

19.4 Minimum weight

- The minimum weight for all participating cars in the MACAU GT CUP race, shall be included the driver and his/her full equipment.
- Vehicles not on the list will need the approval of the Organiser and subject to their classification of class and the minimum weight imposition.
- The Organiser reserves the right to adjust the minimum weight of any car in order to maintain the balance of performance between the cars.

19.5 Success Weight Ballasts

- a) For cars that are not participating in the GT Asia Series 2011, at the MACAU GT CUP race, will be added the following success weight ballasts:
- a.1) 70 kgs - success weight ballasts will be added for GT3 class.
 - a.2) 40 kgs – success weight ballasts will be added for GT (M) Class.

20) FUEL

- 20.1** It must be possible to take 3 litres of fuel at any time during the Event.
- 20.2** The control fuel that will be made available by the organizer can be provided through specific order submitted with the entry form.
- 20.3** As an alternative, unleaded fuel complying with FIA International Sporting Code Appendix J Article 252, 9.1 may be used through out the event.

21) PIT LANE

- 21.1** For the avoidance of doubt and for description purposes, the pit lane will be divided into two lanes. The lane closest to the pit wall will be designated the “fast lane” and the lane closest to the garages will be designated the “inner lane”.
- Other than when cars are at the end of the pit lane under **Article 34.2** the inner lane is the only area where any work can be carried out on a car. However, no work may be carried out in the fast lane if it is likely to hinder other cars attempting to leave the pit lane.
- 21.2** Unless a car is pushed from the grid at any time during the start procedure, cars may only be driven from the teams designated garage area to the end of the pit lane.
- 21.3** Any car(s) driven to the end of the pit lane prior to the start or re-start of a practice session, or any car(s) required to stop at the pit exit during a safety car period, must form up in a line in the fast lane and leave in the order they got there unless another car is unduly delayed.
- 21.4** Any driver that is required to start the race from the pit lane may not drive his car from his teams designated garage area until the 10 minute signal has been given and must stop in a line in the fast lane. Under these circumstances working in the fast lane will be permitted, but any such work is restricted to :
- starting the engine and any directly related preparation
 - changing of wheels when a climatic change has been confirmed
 - When cars are permitted to leave the pit lane they must do so in the order they arrived at the end of the pit lane unless another car is unduly delayed. At all times drivers must follow the directions of the marshals.
- 21.5** Other than drying, sweeping of any tyre rubber left when cars leave their pit stop position, competitors may not attempt to enhance the grip of the surface in the pit lane unless a problem has been clearly identified and a solution agreed to by the Chief Scrutineer.
- 21.6** Competitors must not paint lines on any part of the pit lane.
- 21.7** Other than in **Article 21.4** above no equipment may be left in the fast lane. A car may enter or remain in the fast lane only with the driver sitting in the car behind the steering wheel in his normal position even when the car is being pushed.

- 21.8** Team personnel are only allowed in the pit lane immediately before they are required to work on a car and must withdraw as soon as possible.
- 21.9** It is the responsibility of the competitor to release his car after a pit stop only when it is safe to do so.
- 21.10** Starting an engine with an external device will be considered working on the car, consequently this will not be permitted in the fast lane of the pits.
- 21.11** Cars may not enter the fast lane of the pits until the pit exit is opened at the start or re-start of each practice or qualifying session. Furthermore, no car may be moved to a position in the slow lane which is closer to the pit exit than the garage which has been assigned to the relevant Team.
- 21.12** Under exceptional circumstances the Clerk of the Course may ask for the pit entry to be closed during the race for safety reasons. At such times drivers may only enter the pit lane in order for essential and entirely evident repairs to be carried out to the car.
- 21.13** Cars must be angle-parked in formation at all free practice sessions and qualifying sessions (rear of the car into the pit entry at an angle of approximately 45 degrees facing towards the pit lane exit), even in the case of a change of one or more wheels. Only in this position can cars be worked on when stopped in the pit lane working area.
During the course of an official qualifying session, all competing cars must remain in the pit lane whilst not on the track. At no time will competing cars be allowed in their garage or the paddock areas until such time as the official qualifying session has ended and the car has been cleared from any post-qualifying scrutineering checks and released from the Parc Fermé, except with the express permission of the Chief Scrutineer.

22) SPORTING CHECKS

- 22.1** During initial scrutineering, and at any time during the event, each competitor must have available all documents required by **Article 4.1** above in addition to the car's technical passport.
- 22.2** Unless a waiver is granted by the Stewards, competitors who do not keep to time limits will not be allowed to take part in the Event.
- 22.3** The Organiser may require entrants to fit an Electronic Self Identification Module for the purpose of accurate timing, the exact position of which will be advised prior to the race. These modules will have to be in place and switched on for all practice sessions and the race.

23) SCRUTINEERING

- 23.1** Initial scrutineering of the car will take place at the times indicated in the appropriate Appendix.
- 23.2** Race numbers and any official advertising must be on the car for inspection during scrutineering.
- 23.3** No car may take part in the Event until it has been passed by the scrutineers.
- 23.4** The scrutineers may :
- a) check the eligibility of a car or of a competitor at any time during the Event ;
 - b) require a car to be dismantled by the competitor to make sure that the conditions of eligibility or conformity are fully satisfied ;
 - c) require a competitor to pay the reasonable expenses which exercise of the powers mentioned in this Article may entail ;
 - d) require a competitor to supply them with such parts or samples as they may deem necessary.

- 23.5** Any car which, after being passed by the scrutineers, is dismantled or modified in a way which might affect its safety or call into question its eligibility, or which is involved in an accident with similar consequences, must be re-presented for scrutineering approval.
- 23.6** The Clerk of the Course may require that any car involved in an accident be stopped and checked.
- 23.7** After each race and all qualifying practice sessions at least five classified cars will be selected and must undergo complete scrutineering. Work on all other cars may continue.
- 23.8** Checks and scrutineering shall be carried out by duly appointed officials who shall be responsible for the operation of the parc fermé and who alone are authorised to give instructions to the competitors.
- 23.9** The Stewards will publish the findings of the scrutineers each time cars are checked during the Event. These results will not include any specific figure except when a car is found to be in breach of the Technical Regulations.
- 23.10** All competitors must declare the use of radios and their frequencies to the organizers and seek the necessary permissions and permits prior to their use. Any infringements may result in the confiscation of such equipment for the duration of the Event.

24) TYRE LIMITATION DURING THE EVENT

- 24.1** All tyres must be used as noted in the Specific Regulations or Sporting Regulations (as appropriate). Any modification or treatment including cutting, grooving, the application of water, solvents or softeners, the use of heat retaining (and/or cooling) devices or pre-heating/cooling is prohibited. This applies to both wet-weather and dry-weather tyres.
- 24.2** Wet-weather tyres may only be used if the circuit has been declared wet by the Clerk of the Course.
- 24.3** Dry-weather tyres and Wet-weather tyres may not be mixed on a race car.

25) WEIGHING

- 25.1** a) During each qualifying practice session and race cars will be weighed as follows :
- If a car stops on the circuit and the driver leaves the car, he must go to the weighing area immediately on his return to the pits in order for his weight to be established.
- b) After the race each car crossing the Line may be weighed. If a driver wishes to leave his car before it is weighed he must ask the Chief Scrutineer to weigh him in order that this weight may be added to that of the car.
- c) The relevant car may be excluded should its weight be less than that specified in the Technical Regulations when weighed under a) or b) above, save where the deficiency in weight results from the accidental loss of a component of the car.
- d) No solid, liquid, gas or other substance or matter of whatsoever nature may be added to, placed on, or removed from a car after it has been selected for weighing or has finished the post race scrutineering or during the weighing procedure. (Except by a scrutineer when acting in his official capacity).
- e) Only scrutineers and officials may enter the weighing area. No intervention of any kind is allowed there unless authorized by such officials.
- 25.2** In the event of any breach of these provisions for the weighing of cars the Stewards may drop the driver such number of grid positions as they consider appropriate or exclude him from the race.
- 25.3** Should a competitor damage the weighing scales through negligence sufficiently to render them unusable for the remainder of the practice session, then their practice times from that session will be disallowed and the competitor will be liable to the cost of any necessary repairs.

26) GENERAL CAR REQUIREMENTS

No signal of any kind may pass between a moving car and anyone connected with the car's entrant or driver save for lap timing purposes, legible messages on a pit board, body movement by the driver and verbal communication between a driver and his team by radio.

27) SPARE CARS

Spare cars are not permitted.

28) GENERAL SAFETY

28.1 Official instructions will be given to drivers by means of the signals laid out in the Code. Competitors must not use flags similar in any way whatsoever to these.

28.2 Drivers are strictly forbidden to drive their car in the opposite direction to the circuit's race direction unless this is absolutely necessary in order to move the car from a dangerous position. A car may only be pushed to remove it from a dangerous position as directed by the marshals.

28.3 Any driver intending to leave the track or to go to his pit or the paddock area must signal his intention to do so in good time making sure that he can do this without danger.

28.4 a) During practice, qualifying and the race, drivers may use only the track and must at all times observe the provisions of the Code relating to driving behaviour on circuits.

b) Other than by driving on the track, competitors are not permitted to attempt to alter the grip of any part of the track surface.

28.5 a) If a car stops on the track it shall be the duty of the marshals to remove it as quickly as possible so that its presence does not constitute a danger or hinder other competitors. If any mechanical assistance results in the car rejoining the Stewards may drop the driver such number of grid positions as they consider appropriate if the incident occurs during a practice session or qualifying or exclude him from the race (other than under **Article 30.12(d)**).

b) A driver who abandons his car must leave it in neutral or with the clutch disengaged and with the steering wheel in place.

28.6 Repairs to a car may be carried out only in the paddock, pits and on the grid.

28.7 The Organiser must make two fire extinguishers of 5kg capacity available at each pit and ensure that they work properly.

28.8 Refuelling is not permitted during Practice and qualifying sessions or the race.

28.9 The replenishment of any liquids is forbidden following the start of the race until after post race scrutineering. All orifices for oil filling must be designed in such a way that the scrutineers can seal them.

28.10 Save as specifically authorised by the Code or these Sporting Regulations, no one except the driver may touch a stopped car unless it is in the paddock, the teams designated garage area, the pit lane or on the starting grid.

28.11 At no time may a car be reversed in the pit lane under its own power.

28.12 At no time may a car be driven unnecessarily slowly, erratically or in a manner which could be deemed potentially dangerous to other drivers or any other person. This will apply whether any such car is being driven on the track, the pit entry or the pit lane.

28.13 During the periods commencing five minutes prior to and ending five minutes after every practice session and the periods between the commencement of the formation lap which immediately

precedes each race and the time when the last car enters the parc fermé, no one is allowed on the track, the pit entry or the pit exit with the exception of :

- a) marshals or other authorised personnel in the execution of their duty ;
- b) drivers when driving or on foot, having first received permission to do so from a marshal ;
- c) team personnel when either pushing a car or clearing equipment from the grid after all cars able to do so have left the grid on the formation lap ;
- d) team personnel when assisting marshals to remove a car from the grid after the start of the race.

28.14 During a race, the engine may only be started with the starter except:

- a) in the pit lane or the teams designated garage area where the use of an external starting device is allowed, or ;
- b) under **Article 34.12(b)**.

28.15 Drivers taking part in practice sessions and the races must always wear the clothes and helmet specified in the Code.

28.16 A speed limit of 60km/h will be enforced in the pit lane. Except in the race, any driver who exceeds the limit will be fined US\$50 (fifty US Dollars) for each km/h above the limit. During the race, the Stewards or Clerk of the Course may impose either of the penalties under **Article 12.3** on any driver who exceeds the limit.

28.17 If a driver has serious mechanical difficulties during a practice session or the race he must leave the track as soon as it is safe to do so.

28.18 The car's white headlights, red rear light and rear fog lights must be illuminated at all times when it is running on a track that has been declared a "wet track".

It shall be at the discretion of the Clerk of the Course to decide if a driver should be stopped because his lights are not working. Should a car be stopped in this way, it may re-join the Event when the fault has been remedied.

28.19 Only two team members per participating car (all of whom shall have been issued with and wearing special identification) are allowed in the signalling area during practice and the race.

People under 16 years of age are not allowed in the pits, pit lane, on the pit wall and on the starting grid.

28.20 Animals, except those which may have been expressly authorised by the Organiser for use by security services, are forbidden in the pit area and on the track and in any spectator area.

28.21 The Stewards, the Clerk of the Course or the Medical Delegate can require a driver to have a medical examination at any time during an Event, this medical examination may include an anti-doping test. (ISC – Appendix L, Chapter II, Art. 4)

A Bulletin will be issue at the commencing of the scrutineering of the event, concerning the appropriate procedures of the anti-doping test.

28.22 From the Sunday before the Race, all drivers and all team members which are reported for speeding on the streets used for the racing circuit, when these streets are open to normal traffic, will be brought before the Stewards for their consideration.

28.23 Failure to comply with the general safety requirements of the Code or these Sporting Regulations may result in the exclusion of the car and driver concerned from the Event.

29) PRACTICE SESSIONS

29.1 Save when these Sporting Regulations require otherwise, pit lane and track discipline and safety measures will be the same for all practice sessions as for the race.

- 29.2** No driver may start in the race without taking part in a qualifying practice session unless the Stewards agree to take free practice times into consideration.
- 29.3** During all practice sessions there will be a green and a red light at the end of the pit lane. Cars may only leave the pit lane when the green light is on. Additionally, a blue flag or a flashing blue light will be shown at the pit exit to warn drivers leaving the pit lane if cars are approaching on the track.
- 29.4** If a car stops during a practice session it must be removed from the track as quickly as possible so that its presence does not constitute a danger or hinder other competitors. If the driver is unable to drive the car from a dangerous position, it shall be the duty of the marshals to assist him.
- 29.5** In the event of a driving infringement during any practice session, the Stewards may drop the driver such number of grid positions as they consider appropriate. Unless it is completely clear that a driver committed a driving infringement any such incident will normally be investigated after the relevant session, any penalty imposed shall not be subject to appeal. Where appropriate, regard will also be given to the provisions of **Article 14**.
- 29.6** The Clerk of the Course may interrupt a practice session as often and for as long as he thinks necessary to clear the track or to allow the removal of a car. Whenever possible, the time lost by the suspension of a practice and qualifying session shall be recovered so that the minimum scheduled period for the session may be accomplished. However, it is not compulsory to resume the session or re-run the session to achieve the time criteria. The decision of the Stewards in this matter shall be final. No protest will be accepted as to the possible effects of the interruption / shortened session on the qualification of any Driver. Any driver taking part in any practice session who, in the opinion of the Stewards, stops unnecessarily on the circuit or unnecessarily impedes another driver shall be subject to the penalties referred to in Article 29.5.
- 29.7** Should one or more sessions be thus interrupted, no protest can be accepted as to the possible effects of the interruption on the qualification of drivers admitted to start.
- 29.8** All laps covered during qualifying practice will be timed to determine the driver's position at the start in accordance with **Article 32**.

30) STOPPING THE PRACTICE

Should it become necessary to stop a practice session because the circuit is blocked by an accident or because weather or other conditions make it dangerous to continue, the Clerk of the Course shall order a red flag and the abort lights to be shown at the Line. Simultaneously, red flags will be shown at all marshal posts. When the signal is given to stop, all cars shall immediately reduce speed and proceed slowly back to their respective pits, and all cars abandoned on the track will be removed to a safe place. At the end of each practice session no driver may cross the Line more than once.

31) PRESS CONFERENCES

Drivers must make themselves available to attend Press Conferences as directed. After each final qualifying session all the drivers are required to make themselves available to attend a press conference in the media centre. This will normally take place 15 minutes after the end of the qualifying practice session.

32) THE GRID

- 32.1** At the end of the last qualifying practice, the fastest time achieved by each driver will be officially published.

- 32.2** The grid for the race will be drawn up in the order of the fastest qualifying time achieved by each driver during the two qualifying sessions. Should two or more drivers have identical times, priority will be given to the one who set it first.

The starting grid will be published one hour after the final qualifying. Any competitor whose car is unable to start for any reason whatsoever (or who has good reason to believe that their car will not be ready to start) must inform the Clerk of the Course accordingly at the earliest opportunity and, in any case, no later than one hour and fifteen minutes before the start of the formation lap.

If one or more cars are withdrawn, the starting grid will be closed up accordingly and the final starting grid confirmed one hour before the start of the formation lap. Should two or more drivers have identical times, priority will be given to the one who set it first.

- 32.3** The fastest driver will start the race from the position on the grid which was the pole position in the previous year.

The pole position will be the position on the grid which was the pole position in the previous year or, on a new circuit, has been designated as such by the FIA Circuit Licence.

- 32.4** Any driver whose best qualifying lap exceeds 120% of the pole position time will not be allowed to take part in the race. Under exceptional circumstances however, which may include setting a suitable lap time in a previous free practice session, the Stewards may permit the car to start the race.

Should there be more than one driver accepted in this manner, their order will be determined by the Stewards. In either case, a team will not be able to appeal against the Stewards' decision.

- 32.5** The grid will be in a 2 x 2 formation and the rows on the grid will be separated by 7.2 metres.

33) MEETINGS

- 33.1** A Drivers' meeting will take place on the last day of scrutineering, all drivers entered for the Event and their team managers must be present. Any driver or team not attending and signing the attendance sheet at the meeting will be brought before the Stewards for their consideration.

- 33.2** A further meeting, if deemed necessary by the Clerk of the Course may take place and at a time to be notified to the competitors.

34) STARTING PROCEDURE

- 34.1** 20 minutes before the time for the start of the formation lap, the cars will leave the paddock exit to cover one or more reconnaissance lap. After the completion of the reconnaissance laps they will stop on the grid in starting order with their engines stopped.

Should they wish to cover more than one reconnaissance lap, this must be done by driving down the pit lane at greatly reduced speed between each of the laps.

Any car which has not taken up its position on the grid by the time the five minutes signal is shown, will not be permitted to do so and must start from the pit lane in accordance with Art. 34.2

- 34.2** 12 minutes before the start of the formation lap, a warning signal announcing the closing of the paddock and pit exit in 2 minutes will be given.

10 minutes before the start of the formation lap, the paddock and pit exit will be closed and a second warning signal will be given.

Any car which is still in the pit lane or at the paddock exit can start from the pit lane or paddock exit, provided it reached the end of the pit lane or paddock exit under its own power. If more than one car is affected, they must line up in the order in which they reached the end of the pit lane or paddock exit.

All such cars may then join the race once the whole field has passed the end of the pit lane for the first time after the start.

- 34.3** The approach of the start will be announced by light signals shown ten minutes, five minutes, three minutes, one minute and fifteen seconds before the start of the formation lap, each of which will be accompanied by an audible warning.

When the ten minute signal is shown, everybody except drivers, officials and team technical staff must leave the grid.

- 34.4** When the five minute signal is shown all cars must have their wheels fitted and the car must be resting on their wheels, after this signal wheels may only be removed in the pit lane, or on the grid during a race Suspension. A thirty seconds time penalty will be imposed on any driver whose car did not have all its wheels fully fitted at the five minute signal.

- 34.5** When the one minute signal is shown, engines should be started and all team personnel must leave the grid by the time the 15 second signal is given, taking all equipment with them. If any driver needs assistance after the 15 second signal he must raise his arm and, when the remainder of the cars able to do so have left the grid, marshals will be instructed to push the car into the pit lane. In this case, marshals with yellow flags will stand beside any car (or cars) concerned to warn drivers behind.

- 34.6** When the green lights are illuminated, the cars will begin the formation lap with the organiser's official leading car leading, maintaining their starting order. When leaving the grid, all drivers must respect the pit lane speed limit until they pass pole position. Marshals will be instructed to push any car (or cars) which remain on the grid into the pit lane by the fastest route immediately after the cars able to do so have left the grid, the mechanics may then work on the car again. If successful the car may then start from the pit lane.

Any driver being pushed from the grid may not attempt to start the car and must follow the instructions of the marshals.

- 34.7** During the formation lap practice starts are forbidden and the formation must be kept as tight as possible.
- 34.8** Overtaking during the formation lap is only permitted if a car is delayed and cars behind cannot avoid passing it without unduly delaying the remainder of the field. In this case, drivers may only overtake to re-establish the original starting order. Any driver delayed in this way, and who is unable to re-establish the original starting order before he reaches the first safety car line, must enter the pit lane and start from the end of the pit lane as specified in Article 34.2.
- 34.9** The speed of the organiser's official leading car must be around 80kph during the formation lap. The official leading car will pull off at the end of the formation lap. The cars will continue on their own with the pole position leading at a minimum speed of 70 km/h and a maximum of 90 km/h. A judge of fact will monitor the speed of the car in pole position by radar. Any divergence between the prescribed speeds (70/90 km/h) before the start is given will result in a sixty seconds time penalty added to the total race time. During the formation lap the red light will be on. No car may overtake another one before the starting signal is given.

Maintain Grid position - Drivers should line up directly behind the other driver ahead. Distance between cars side by side must be at least 1 Car Width apart and distance between cars front to back must be at least 1 Car Length, not exceeding 3 Cars Length.

- a) This will be a rolling start. The race will be started by extinguishing all the red lights activated under the control of starter.
During the start of a race, the pit wall must be kept free of all persons with the exception of properly authorised officials and fire marshals, all of whom shall have been issued with and shall be wearing the appropriate pass.
- b) If a problem arises when the cars reach the Line at the end of the formation lap, the red light will stay on. Yellow flags will be displayed at all observation posts. The cars, with the pole position leading, will complete a new formation lap. They may be joined and led by another official leading car and will continue for another formation lap.
- c) If additional formation laps are necessary, only the first two laps will not count towards the total distance of the race. The total number of additional laps, whether they be formation laps or covered behind the Safety Car is two. If more than two additional formation laps are necessary, the start will be considered as having been given at the end of the second additional formation lap. The Race Starter will be the Judge of fact.
All cars starting from the pit lane must be stopped by the marshals at the pit lane exit. These cars are considered to have started as soon as released by the marshals. The lights at the pit lane exit must be strictly observed. Cars starting from the pit lane will have completed their first lap as soon as they cross the start/finish line for the first time.

If the Clerk of the Course is satisfied with the formation, he will Start the race by extinguishing all the Red lights. Once the Red lights are extinguished, race is deemed started, and overtaking is allowed.

34.10 Only in the following cases will any variation in the starting procedure is allowed:

- a) If it starts to rain after the five minute signal but before the race is started and, in the opinion of the Clerk of the Course, Teams should be given the opportunity to change tyres, a “start delayed” board will be shown on the Line. There will be a delay of five minutes, in which Competitors may change tyres on the Grid, and then the normal start procedure will recommence from the “ three-minute “ signal. In this case, it may determine the new Race distance and maximum Race duration.
- b) If the start of the race is imminent and, in the opinion of the Clerk of the Course, the volume of water on the track is such that it cannot be negotiated safely even on wet-weather tyres, the Clerk of the Course may delay the start of the race by showing a “start delayed” board simultaneously with a “10” board with a red background.

This “10” board with a red background will mean that there is to be a delay of ten minutes before the starting procedure can be resumed. If weather conditions have improved at the end of that ten minute period, a “10” board with a green background is shown. The “10” board with a green background will mean that the green flag will be shown in ten minutes. Five minutes after the “10” board with the green background is shown, the starting procedure will begin and the normal starting procedure signals (i.e.5, 3, 1 min, 15 seconds) will be shown, accompanied by an audible warning.

If however, the weather conditions have not improved within ten minutes after the”10” board with the red background was shown, the “10” board with the red background will be shown again which will mean a further delay of ten minutes before the starting procedure can be resumed.

This procedure may be repeated several times. At any time when a “10” board (with either a red or green background) is shown, it will be accompanied by an audible warning.

In exceptional circumstances, the Race may be started behind the Safety Car. In this case, at any time before the one minute signal, the Safety Car will be placed in front of Grid with orange lights illuminated. This is the signal to the drivers that the race will be started behind the safety car. When the green lights are illuminated at the Start Line, the Safety Car will leave the grid with all cars following in grid order no more than 5 cars lengths apart. There will be no formation lap and the race will start when the green lights at the start line are illuminated.

Soon after the last car in line behind the safety car passes the end of the pit lane, the pit exit light will turn green; any car in the pit lane may then enter the track and join the line of cars behind the safety car.

34.11 The Stewards may use any video or electronic means to assist them in reaching a decision. The Stewards may overrule judges of fact. A breach of the provisions of the Code or these Sporting Regulations relating to the starting procedure, may result in the exclusion of the car and driver concerned from the Event.

35) THE RACE

35.1 Team orders which interfere with a race result are prohibited.

35.2 A race will not be stopped in the event of rain unless the circuit is blocked or it is dangerous to continue.

35.3 If a car stops during the race, it must be removed from the track as quickly as possible so that its presence does not constitute a danger or hinder other competitors. If the driver is unable to drive the car from a dangerous position, it shall be the duty of the marshals to assist him. If any such mechanical assistance (for example tow, crane, snatch vehicle, telescopic handler or the like) results in the engine starting and the driver rejoining the race, the car will be excluded from the results of the race.

35.4 During the race, drivers leaving the pit lane may only do so when the light at the end of the pit lane is green and on their own responsibility. A marshal with a blue flag, and/or a flashing blue light, will also warn the driver if cars are approaching on the track.

36) SAFETY CAR

36.1 The FIA approved safety car will be driven by an experienced circuit driver. It will carry an FIA approved observer capable of recognising all the competing cars, who is in permanent radio contact with race control.

36.2 20 minutes before the start of the formation lap the safety car will take up position at the front of the grid and remain there until the five minute signal is given. At this point (except under **36.14** below) it will cover a whole lap of the circuit and take up position.

36.3 The safety car may be brought into operation to neutralize a race upon the order of the Clerk of the Course.

It will be used only if competitors or officials are in immediate physical danger but the circumstances are not such as to necessitate suspending the race.

- 36.4** When the order is given to deploy the safety car, all marshals' posts will display waved yellow flags and "SC" boards for the duration of the intervention.
- 36.5** No car may be driven unnecessarily slowly, erratically or in a manner which is deemed potentially dangerous to other drivers or any other person at any time whilst the safety car is deployed. This will apply whether any such car is being driven on the track, the pit entry or the pit lane.
- 36.6** The safety car will join the track with its orange lights illuminated and will do so regardless of where the race leader is.
- 36.7** All competing cars must then reduce speed and form up in line behind the safety car no more than ten car lengths apart.

With the following exceptions, no car may overtake until it has passed the Line for the first time when the safety car is returning to the pits. However, if the safety car is still deployed at the beginning of the last lap, or is deployed during the last lap, **Article 36.13** will apply.

- if a car is signalled to do so from the safety car ;
 - **under 36.14** below ;
 - when entering the pits any car may pass another car including the safety car remaining on the track after it has crossed the first safety car line ;
 - when leaving the pits any car, including the safety car may overtake or be overtaken by another car on the track before it crosses the second safety car line ;
 - when the safety car is returning to the pits it may be overtaken by cars on the track once it has crossed the first safety car line ;
 - any car stopping in its designated garage whilst the safety car is using the pit lane (see **36.10** below) may be overtaken ;
 - if any car slows with an obvious problem.
- 36.8** When ordered to do so by the Clerk of the Course, the observer in the car will use a green light to signal to any cars between it and the race leader that they should pass. These cars will continue at reduced speed and without overtaking until they reach the line of cars behind the safety car.
- 36.9** The safety car shall be used at least until the leader is behind it and all remaining cars are lined up behind him.

Once behind the safety car, the race leader must keep within ten car lengths of it (except under **36.11** below) and all remaining cars must keep the formation as tight as possible.

- 36.10** Whilst the safety car is in operation, competing cars may enter the pit lane, but may only rejoin the track when the green light at the end of the pit lane is on. It will be on at all times except when the safety car and the line of cars following it are about to pass or are passing the pit exit. A car rejoining the track must proceed at an appropriate speed until it reaches the end of the line of cars behind the safety car.

Under certain circumstances the Clerk of the Course may ask the safety car to use the pit lane. In these cases, and provided its orange lights remain illuminated, all cars must follow it into the pit lane without overtaking. Any car entering the pit lane under these circumstances may stop at its designated garage area.

- 36.11** When the Clerk of the Course decides it is safe to call in the safety car, it must extinguish its orange lights, this will be the signal to the drivers that it will be entering the pit lane at the end of that lap.

At this point the first car in line behind the safety car may dictate the pace and, if necessary, fall more than ten car lengths behind it.

In order to avoid the likelihood of accidents before the safety car returns to the pits, from the point at which the lights on the car are turned out drivers must proceed at a pace which involves no erratic acceleration or braking or any other manoeuvre which is likely to endanger other drivers or impede the restart.

As the safety car is approaching the pit entry the yellow flags and SC boards will be withdrawn and, other than on the last lap of the race, replaced by waved green flags with green lights at the Line. These will be displayed until the last car crosses the line.

36.12 Each lap completed while the safety car is deployed will be counted as a race lap.

36.13 If the safety car is still deployed at the beginning of the last lap, or is deployed during the last lap, it will enter the pits at the end of the last lap and the cars will take the chequered flag as normal without overtaking.

36.14 Under certain circumstances the race may be started behind the safety car or resumed in accordance with **Article 38.5**. In either case, at the ten minute signal its orange lights will be illuminated, this being the signal to the drivers that the race will be started or resumed behind the safety car.

When the green lights are illuminated, the safety car will leave the grid with all cars following in grid order no more than ten car lengths apart. During a race start there will be no formation lap and race will start when the green lights are illuminated.

Overtaking, during the first lap only, is permitted if a car is delayed when leaving its grid position and cars behind cannot avoid passing it without unduly delaying the remainder of the field. In this case, drivers may only overtake to re-establish the original starting order.

Any driver delayed in this way, and who is unable to re-establish the original starting order before he reaches the first safety car line, must enter the pit lane and may only join (or rejoin) the race once the whole field has passed the end of the pit lane.

The penalties under **Article 12.3** will be imposed on any driver who, in the opinion of the Stewards, unnecessarily overtook another car during the first lap.

37) SUSPENDING A RACE

37.1 Should it become necessary to suspend the race because the circuit is blocked by an accident or because weather or other conditions make it dangerous to continue, the Clerk of the Course will order red flags to be shown at all marshal posts and the abort lights to be shown at the Line.

37.2 When the signal is given overtaking is forbidden, the pit exit will be closed and all cars must proceed slowly to the starting grid. The first car to arrive on the grid should occupy pole position and others should fill the remaining grid positions in the order they arrive.

If the safety car has been directed into the pit lane (**see Article 36.10**) cars should stop in line in the fast lane of the pits.

37.3 If any cars are unable to return to the grid as a result of the track being blocked they will be brought back when the track is cleared and will be arranged in the order they occupied before the race was suspended. The order will be taken at the last point at which it was possible to determine the position of all cars. Any such cars will then be permitted to resume the race.

The safety car will then be driven to the front of the grid.

37.4 Whilst the race is suspended :

- neither the race nor the timekeeping system will stop ;
- cars may be worked on once they have stopped on the grid or entered the pits but any such work must not impede the resumption of the race ;
- refuelling is forbidden ;

- only team members and officials will be permitted on the grid.

37.5 Cars may not enter the pit lane when the race is suspended. A penalty (see **Article 12.3**) will be imposed on any driver who enters the pit lane or whose car is pushed from the grid to the pit lane after the race has been suspended. Any car which was in the pit entry or pit lane when the race was suspended will not incur a penalty. However, if the cars have been directed into the pit lane (see **Articles 36.10 and 37.2**) a penalty will only be imposed on any driver whose car is moved from the fast lane to any other part of the pit lane.

All cars in the pit lane will be permitted to leave the pits once the race has been resumed, but any which were in the pit entry or pit lane when the race was suspended will be released before any others. Subject to the above, any car intending to resume the race from the pit exit may do so in the order they got there under their own power, unless another car was unduly delayed.

At all times drivers must follow the directions of the marshals.

38) RESUMING A RACE

38.1 The delay will be kept as short as possible and as soon as a resumption time is known teams will be informed via the timing monitors, in all cases at least ten minutes warning will be given.

38.2 Signals will be shown ten minutes, five minutes, three minutes, one minute and fifteen seconds before the resumption and each of these will be accompanied by an audible warning.

38.3 When the five minute signal is shown all cars must have their wheels fitted, after this signal wheels may only be removed in the pit lane, or on the grid during a further race suspension. If the race has been suspended in the pit lane (see **Article 37.2**) all cars in the fast lane must have their wheels fitted at the five minute signal.

A thirty seconds time penalty will be imposed on any driver whose car did not have all its wheels fully fitted at the five minute signal.

Five minutes before the race resumption time, any cars between the safety car and the leader, will be waved off to complete a further lap, without overtaking and join the line of cars behind the safety car.

38.4 When the one minute signal is shown, engines should be started and all team personnel must leave the grid by the time the 15 second signal is given taking all equipment with them. If any driver needs assistance after the 15 second signal he must raise his arm and, when the remainder of the cars able to do so have left the grid, marshals will be instructed to push the car into the pit lane. In this case, marshals with yellow flags will stand beside any car (or cars) concerned to warn drivers behind.

38.5 The race will be resumed behind the safety car when the green lights are illuminated. The safety car will enter the pits after one lap unless:

- a) the race is being resumed in wet conditions and the Clerk of the Course deems more than one lap necessary, in which case see **Article 36.14** ;
- b) all cars are not yet in a line behind the safety car ;
- c) team personnel are still clearing the grid ;
- d) a further incident occurs necessitating another intervention.

When the green lights are illuminated the safety car will leave the grid with all cars following no more than ten car lengths apart. Soon after the last car in line behind the safety car passes the end of the pit lane (including any cars which were waved off **under 38.3 above**) the pit exit light will be turned green, any car in the pit lane may then enter the track and join the line of cars behind the safety car.

38.6 Overtaking during the lap is permitted only if a car is delayed when leaving the grid and cars behind cannot avoid passing it without unduly delaying the remainder of the field. In this case, drivers may only overtake to re-establish the order before the race was suspended.

Any driver delayed in this way, and who is unable to re-establish the original starting order before he reaches the first safety car line, must enter the pit lane and may only rejoin the race once the whole field has passed the end of the pit lane.

38.7 Either of the penalties under **Article 12.3** will be imposed on any driver who, in the opinion of the Stewards, unnecessarily overtook another car during the lap. During this lap **Articles 36.11, 36.12, 36.13 and 36.14** will apply.

38.8 If the race cannot be resumed the results will be taken at the end of the penultimate lap before the lap during which the signal to suspend the race was given.

39) FINISH

39.1 The end-of-race signal will be given at the Line as soon as the leading car has covered the full race distance in accordance with **Article 5.4**.

39.2 Should for any reason the end-of-race signal be given before the leading car completes the scheduled number of laps, the race will be deemed to have finished when the leading car last crossed the Line before the signal was given. Should the end-of-race signal be delayed for any reason, the race will be deemed to have finished when it should have finished.

39.3 After receiving the end-of-race signal all cars must proceed on the circuit directly to the parc fermé without any unnecessary delay without overtaking (unless clearly necessary) without receiving any object whatsoever and without any assistance (except that of the marshals, if necessary).

Any classified car which cannot reach the parc fermé under its own power will be placed under the exclusive control of the marshals who will take the car to the parc fermé.

A Lap Counting Panel will be installed at the left side of the track near the Line for information purpose only and do not have any decisive action under the Code and these Regulations.

40) PARC FERMÉ

40.1 Only those officials charged with supervision may enter the parc fermé. No intervention of any kind is allowed there unless authorised by such officials.

40.2 When the parc fermé is in use, parc fermé regulations will apply in the area between the Line and the parc fermé entrance.

40.3 The parc fermé shall be sufficiently large and secure that no unauthorised persons can gain access to it. Parc Fermé is situated behind garage 1.

41) CLASSIFICATION

41.1 The overall winner will be the car which completes the Race in the shortest time.

41.2 Cars having covered less than 90% of the number of laps covered by the winner (rounded down to the nearest whole number of laps), will not be classified.

41.3 The official classification will be published after the race. It will be the only valid result subject to any amendments which may be made under the Code and these Sporting Regulations.

42) PODIUM CEREMONY

The drivers finishing the race in 1st, 2nd or 3rd positions must attend the prize-giving ceremony on the podium and abide by the podium procedure as directed by the Organiser and immediately thereafter make themselves available for a period of 90 minutes for the purpose of television interviews and the press conference in the media centre situated on the first floor of the pit building.

43) AWARDS

The awards for each race are noted in the appropriate Specific Regulations Appendix.

44) PRIZE GIVING

All drivers are requested to attend the Official Prize Giving on the 20th November 2011 at a location and time to be notified.

45) ADVERTISING AND RIGHTS

- 45.1** All advertising on/in cars, drivers and teams must comply with the local legal requirements and national restrictions required in order to permit the host broadcaster to transmit the event. If required by the Organiser, all cars must have the official sticker displayed in such a manner as to be visible to a forward facing camera.

The organizers reserve the right to place advertising strip across the top width of the front windshield. The decision for the positioning of this sticker rests solely with the Organiser. No other sticker will be allowed on the front windshield.

Any other in-car advertising, including on the driver's helmet and overalls, will only be allowed at the discretion of the Organiser. In the event of a dispute, the final decision rests with the Organiser.

All competitors give the right to the Organiser to fit an on-board camera to any car provided that this meets the requirements of the Chief Scrutineer. All cars must provide space for the Organiser stickers to be attached representing the tyre and fuel suppliers and Organizers sponsors.

- 45.2** All audio/visual rights in accordance with the FIA Regulations and trademarks and copyrights relating the Event are the property of the respective Event's Organiser.
- 45.3** All cars must have the starting numbers fitted as required by the Organiser and without modification unless agreed by the Organiser. No additional material or advertising may be added to the start number panels.
- 45.4** Any identification of a conflicting company to the appointed official company must be removed – both from the car and the drivers' overalls.

TECHNICAL REGULATIONS FOR GT ASIA SERIES 2011 and GT (M) Class

1. CHASSIS

Reference to the bodywork in these regulations includes chassis or body-shell.

It is permitted to fit an on-board pneumatic system but the compressed air bottle must not be carried in the car.

2 BODYWORK

Only those aerodynamic devices that are permanently mounted on the bodywork will be allowed. The scrutineers will be the sole arbiters in any dispute concerning the eligibility of aerodynamic devices.

It is permitted to bend inwards the metal edges of the wheel arches, or to shorten the inner edges of plastic (non-metallic) wheel arches. Sound-deadening material and plastic liners may be removed from the wheel arch area. Plastic part in the wheel arch area may be replaced with aluminum ones of the same shape.

Insulating or corrosion protection material may be removed.

Exterior decorative trim parts may be removed. All parts that follow the outer contours of the bodywork and measure less than 25 mm in any direction are considered as trim items.

Bumper mountings are free, provided that the bodywork and the shape and the position of the bumper mountings are not altered.

Production openings in the bodywork such as fog lamps may be used as air intakes for the brakes.

As long as the production apertures are not modified, it is permitted to fasten ducting to them.

It is not permitted to add an under tray unless original manufacturer had one installed.

The front screen wiper blades may be replaced. Any rear screen wiper blade and wiper motor fitted may be removed.

Left and right door mirrors must be fitted. Rear-view mirrors are free, provided that their surface area is of at least 90-cm sq.

It is permitted to strengthen the whole body by welding or by the addition of material. This means that for example it is permitted to add a second suspension strut turret over the original by welding. When adding material, the principle must be borne in mind that any added material must follow the contours of the original and must be in contact with it.

3 INTERIOR BODYWORK

The driver's seat must be changed to an FIA approved racing seat.

Original glass windscreens (including side and rear screens) may be changed to lightweight racing replacements as long as they fulfill certain restrictions such as those imposed by other international racing standards. This may include certain thickness and construction of certain materials.

Electric windows may be replaced by manual ones. The lifting mechanism of the rear door windows is free.

Air conditioning system may be removed.

It is permitted to use either a left hand or a right hand drive car. The spare wheel must be removed.

The function of all controls must be as foreseen by the manufacturer. It is permitted to make foot controls more easily usable by adding an additional block to the pedals.

The following in particular are permitted:

- a. Additional measuring instruments, gauges, etc, provided that their fitment does not create a danger.

APPENDIX ZERO

- b. The horn may be removed.
- c. The hand-brake mechanism is free, and may be modified to provide instant release (fly off) or removed entirely.
- d. Seat mountings are free provided that they respect the provisions of Art. 253.16 of Appendix J of the FIA Yearbook.
- e. It is permitted to add extra compartments to the glove box or in the doors.
- f. The steering wheel is free.
- g. It is permitted to remove any non-structural panels situated below the dashboard. Instrumentation is free. It is permitted to remove the part of the center console that does not contain heating controls or instruments.
- h. Unused mounting bolts and brackets that are protruding from the basic bodywork may be removed, except that part of any bracket actually fixed to and flush with the bodywork must remain.
- i. It is permitted to remove the sound deadening material from the boot. It is permitted to remove sound deadening material from under the bonnet. It is permitted to remove an engine (noise proofing) capsule. In all cases the weather-strip must remain in its original position.

4 ENGINE, CAMSHAFT AND VALVES

- The position of the engine must not be altered.
- The original stock engine type for the vehicle must be used as supplied by the original manufacturer.
- The additional weight for modification to camshaft, valves or head + **50 kgs**
For camshaft -Change of OE Lobe displacement angle
- The additional weight for modification to piston or capacity cc of cylinder + **50 kgs**
For piston-Change of OE compression ratio
Change of OE cylinder displacement
- Any engine changed must inform the Race Committee.
- The cars may be required to move up to a higher Class
- The Organiser reserves the right to re-classify any of the cars or give additional ballast to individual car before each race.

5 CYLINDER HEAD

The material of the cylinder head gasket is free.

6 IGNITION

The manufacturer and type of spark plug, rev limiter, high-tension cables and ignition components is free.

7 COOLING

The thermostat, as well as its control system and the temperature at which it opens, is free.

The radiator and its air ducting are free, as long as the radiator is installed in its original position, and its installation and the installation of its air ducting do not result in any alterations to the original bodywork. The added air ducting behind the radiator must not exceed the outer dimensions of the radiator (with a tolerance of + 2 cm) and the end of the duct may only extend as far as the vertical plane of the front axle center, as a maximum.

The original radiator and coolant container may be replaced by another with an increase in capacity of up to 2 litres larger. The coolant container must be installed in the engine bay; otherwise the coolant container is free. Water hoses and/or pipes, other than those within the engine or the engine ancillaries, are free. The fan is free.

Oil coolers are free, but the bodywork must not be altered by the installation. It is only permitted to install the oil cooler outside the bodywork if it is below the wheel centerline, but it must not protrude beyond the periphery of the car when viewed from above.

8 MIXTURE FORMATION

It is permitted to double or to replace the accelerator cable with another irrespective of its manufacturer.

Fuel injection: the original type of fuel injection system must be retained.

The fuel injection electronic management system is free. All sensors and switches of the electronic management system are free. The standard sensors may be freely replaced by different transmitters, but not added to.

The fuel injectors are free, provided their operating principle and location (including the dimensions of the port) remain unmodified.

The measures permitted above may have no influence on the quantity of inducted air, which must remain as production specification.

9 AIR INTAKE AND FILTER

All air to be used for combustion must pass through an air filter. Air ducting ahead of the air filter housing is free. Air ducting from the air filter housing to the throttle-valve housing (carburetor/fuel injection unit) is free.

The air filter is free. All air entering the system must pass through this air filter to engine.

The air filter housing may have only one exit ducting air to the throttle valve housing.

The vehicle original manufacturer injection & intake system must be retained.

The electronic injection control unit is free.

10 LUBRICATION

Baffle plates within the production oil sump are free, and the capacity of the production oil sump may be increased.

Dry Sump is permitted. Remote positioning is allowed.

Oil filters may be freely replaced by others, provided they correspond to the original.

Oil filters may include replacement screw-on type oil filter cartridges.

These may be replaced as long as they respect the following points:

All oil must pass through the oil filter.

The oil filter must filter dirt particles, but it is permitted to increase the oil flow rate relative to the original.

It is forbidden to modify the connection for the oil filter housing.

APPENDIX ZERO

An air/oil separator with a capacity of at least 2 litres may be installed in the engine bay. The oil may only return by gravity to the engine. Gases must be routed back to the inlet system through a pipe connected to the air intake pipe, fixed between the Air Cleaner and throttle body.

11 ENGINE MOUNTINGS

Engine mountings may be replaced, providing the number remains the same and the installation of the engine is not altered.

12 SUSPENSION AND STEERING FRONT AXLE

The production suspension mounting bushes may be changed for other bushes (e.g. silent blocks for harder rubber, aluminum bushes, and spherical bearings). The new mounting points and pivot points of the suspension may be moved up to a maximum of 20 mm from the original mounting and pivot points. The production suspension parts may not, with the exception of the addition of the circlip grooves, be modified. This means that, after removing the suspension mounting elements, the production suspension mounting elements (e.g. the production silent blocks) must be able to be reinserted in working order in the respective suspension parts.

The suspension joints (ball joints on the wheel-hub side of control arms or suspension arms) may be replaced. The position of the new rotation points may vary spatially by a maximum of 20mm, with regard to the rotation point of the original production suspension joint.

The steering track rods must remain as production; their joints at the wheel-hub end are free.

The top mounts of a combined spring/damper unit (McPherson strut) on the front axle are free, provided that the production mounting points on the body-work are retained and that each is mounted no further than 20 mm from the standard mounting points. Modifications to the body, work are not permitted, except to add up to 3 holes with a maximum diameter of 10.5 mm in the strut turret in order to mount the McPherson strut. It is permitted to use these mounting points on the wheel housing for the suspension strut as a means to adjust the camber of the front axle.

13 REAR AXLE

The production suspension mounting elements may be changed for other elements (e.g. silent blocks for harder rubber, aluminum bushing, and spherical bearings). The new mounting points and pivot points of the suspension may be moved up to a maximum of 20mm from the original mounting and pivot points. The production suspension parts may not, with the exception of the addition of circlip grooves, be modified. This means that, after removing the suspension mounting elements, the production suspension mounting elements (e.g. the production silent blocks) must be able to be reinserted in working order in the respective suspension parts.

Multi-link rear axles: It is permitted to elongate existing holes in the suspension arms and/or suspension mounting support structures (sub-frames, axle-carriers) up to a maximum of 10mm in both directions.

Single-link axles: The production suspension arms may be modified to permit camber: and track adjustment. But the arrangement of spring and damper, and the distance from the pivot point of the suspension arm to the wheel-hub center, must remain as production.

Rear axles in general: The modifications permitted for the rear axle does not permit modifications to the bodywork.

14 GENERAL

It is freely permitted to exchange the production anti-roll bars for others, providing these are mounted in the production locations. Anti-roll bars must be made of steel, and may not be adjustable from the cockpit.

APPENDIX ZERO

Strengthening of the suspension and its mounting points is permitted by the addition of material, subject to these regulations.

The production wheel bearings may be exchanged for stronger bearings of the same type with the same dimensions as production bearing (outer and inner diameters and width)

The production suspension bushes on the chassis and/or the suspension sub-frame may be exchanged for others (e.g. silent blocks of harder rubber, metal bushes, plastic bushes, etc.). But the position of the sub-frame or *the* mounting support structure must be maintained when measured in all three dimensions in an unloaded condition in relation to the production vehicle. It is prohibited to modify in any way the bodywork, the chassis, the suspension sub-frame or the original mounting points. That means that it must be possible at all times to refit the original suspension bushes to the chassis/sub-frame, and refit the chassis/sub-frame to the body work, in its production location.

15 SPRINGS

Coil springs: Coil springs are free, providing they respect the following conditions. The number is free, providing the springs are co-axial and that the type of spring corresponds to the production spring. Spring seats may be adjustable, if the adjustable element is a part of the spring seat, and is separate from the suspension arm and the bodywork.

It is permitted to install a device(s) to prevent dislodgment of the springs from their locations.

16 DAMPERS

Dampers are free; but must respect the number, type (telescopic, lever arm) working principle, (hydraulic, friction) and mounting points of the production vehicle.

Providing that the damper has no guiding or load bearing function, a solid bush may be replaced by a spherical bearing, or another joint (e.g. a stiffer rubber or an aluminum sleeve).

Gases filled dampers are considered to have the same working principle as hydraulic dampers.

If it is necessary when replacing the damping element of a McPherson strut or a similar suspension device, to replace the whole suspension strut, the replacement must be mechanically equivalent and use the same mounting points as the original production unit. In McPherson suspension, the shape, dimension and material of the spring seats is free, and they may be adjustable.

In the case of a hydro pneumatic suspension, the volume, shape and material of the spheres may be changed, but not their number.

17 REINFORCEMENTS

Reinforcement-bars may be fitted on the suspension mounting points of the same axle, on the body-shell or chassis, on each side of the car's longitudinal axis, on condition that they are removable and attached by means of bolts. The distance between a suspension attachment point and an anchorage point of the bar may not be greater than 100mm unless the bar is a transversal strut homologated with the roll bar, and unless there is an upper bar attached to a McPherson suspension or similar. In order to attach the transversal strut, it is permitted to make three holes with a maximum diameter of 8.5mm, each in the chassis, on each side of the same axle. In the latter case, the maximum distance between an anchorage point of the bar and upper articulation point will be 150mm.

Mounting eyes for the reinforcement bar (transverse strut) may be welded to the bodywork.

18 TRANSMISSION GEARBOX

The Vehicle standard production gearbox must be used.

The gear ratio is free.

APPENDIX ZERO

The internals of the gearbox are otherwise free (except that only steel components are allowed) the reverse gear must be included and capable of being operated by the driver when seated in the driving seat.

The gearbox mountings are free, providing the number remains the same and installation of the gearbox is not altered.

Gearbox and differential oil coolers are permitted. To this end it is permitted to create a maximum of two holes in the gearbox. These holes may only be used for the inlet and outlet connections to the oil cooling circulatory system.

The production bearings of the production gearshift linkage may be replaced freely by other bearings. The gearshift shall be direct linkage, "H" pattern and its production fixing points to the bodywork, sub-frame, and gearbox, etc, may not be altered.

The standard production gear lever may be extended and the gear lever must enter the cockpit through its original production aperture, which must not be modified.

If a breather is not fitted, a hole is permitted as long as it is connected to a gas box

19 CLUTCH

The clutch is free. The type, operating principle, and the means of fixing to the flywheel must remain as the production car specification.

In the case of a car fitted as standard with a two-mass flywheel, it is permitted to replace this with a single element flywheel made from a ferrous material. It is not permitted to alter from the production dimension, the outer diameter dimension of the friction surface for the clutch disc, nor the starter teeth ring.

20 DIFFERENTIAL

The Final Drive ratio is free.

It is permitted to install a limited slip differential in the production drive axle housing.

21 DRIVE SHAFTS

The drive shafts between the differential and the wheels are free, providing that their material is steel and the production constant velocity joints on the wheel side are used.

22 ELECTRICAL SYSTEM CABLING

The engine-wiring loom is free. In other respects the wiring system is free, provided that the provisions that follow are respected.

23 BATTERY

The manufacturer and capacity of the battery are free. It must be possible to start the engine at all times by means of the on-board battery. The battery must be securely fixed and covered so that leaks and short-circuiting is not possible. If the battery is not located in its production location, it must be secured to the body work by means of a metallic seat and two bolted, metal straps covered with insulation. The bolts used must have a minimum diameter of 10mm. between each bolt and the metal work there must be an underlay of at least 3mm thickness and 20mm sq. surface area.

The battery must be housed in a leak-proof container with a cover that is fastened in place. Its location is free, and may be re-located in the passenger area, provided that, it is behind the front seats. In this case, the cover must have a breather that is vented to the outside of the passenger area.

24 ALTERNATOR

The alternator may be replaced by a more powerful unit.

25 LIGHTING

The original lighting with the exception of fog lamps must be retained, and must be functional at all times during the event. The headlamp glass may be taped at the bottom and the top. However, a 4-cm wide parallel strip, symmetrical to the headlight bulb, must be left uncovered across the whole width of the headlamp.

Fog lamps may be removed. The resulting apertures may be used as described otherwise they may be blanked over.

26 FUSES

It is permitted to add additional fuses to the electrical system.

27 TELEMETRY

No type of data transmission from the moving vehicle is permitted. Impulse senders for lap timing devices are permitted, as long as these are not connected to the engine management system. On board data acquisition systems are permitted.

28 BRAKING SYSTEM

The vehicle Discs and material as per original manufacturer.

The Brake system and Discs is free, provided that it uses the original mounting points.

Liquid cooling is not permitted.

The following apply to whole brake system.

It is permitted to replace the production brake master cylinder, but the mounting point must not be altered.

Brake linings and their fixings are free.

It is permitted to fit a brake balance bar or valve between the front and rear brakes.

It is permitted to remove or disable a brake servo system.

It is permitted to relocate brake lines, provided that Art 253.3 of Appendix J of the FIA Year Book is respected. It is permitted to replace the production brake lines with aviation standard lines. The arrangement of the dual brake circuits is free.

It is permitted to use apertures in the production bodywork such as mounting point for fog lamps, as inlets for brake cooling ducts

Brake shields may be removed or their shape altered

Rubber brake hoses are not permitted.

29 WHEELS

Wheels must be made of a metallic material, otherwise wheels are free.

It is permitted to replace wheel fixings by bolts with studs and nuts, provided that the number of fixing points is not altered and the diameter of the parts that may be bolted on, respects the above and remains unchanged.

The uppermost half of the complete wheel (wheel and tyre) must be hidden by the wheel arch when viewed from above.

30 FUEL TANK

The standard fuel tank is acceptable and no modification is allowed.

Safety tanks complying' with FIA specification is allowed, installed either in the boot or the production location.

APPENDIX ZERO

Re-fueling only from outside of the car. The location of the filler is free; except it is not permitted to locate on a glass surface and it may not stand protrude of the bodywork.

The total capacity of the entire fuel system of safety tank must be no greater than 110 litres.

The construction between the filler and the fuel tank must be fireproof and leak-proof, as must be the breather from the fuel tank. In the case of a fuel tank installed in the luggage area of a hatchback car, it must be enclosed in a fireproof and leak-proof casing; in all other cases there must be a fireproof and leak-proof bulkhead installed between the passenger area and the boot.

Aviation standard fuel lines must be used; otherwise fuel lines are free, providing they respect the provisions of Art. 253.3 of Appendix J of the FIA Year Book.

Fuel pumps: Type is free but only two additional fuel pumps (over the number fitted to the production model) are permitted.

31 EXHAUST SILENCING

The exhaust system is the free downstream of the cylinder head provided the prescribed sound level is not exceeded.

The maximum permitted noise level is 110 dB (A) measured at 0.5 meters from the exhaust outlet at an angle of 45 degrees to the direction *of* travel of the car at 5,000 rpm, in accordance with FIA noise-measuring method.

The exhaust pipe outlet must be situated at the rear of the car and must point rearwards, between the rear wheels and must also be situated no more than 10cm inboard of, nor protruding beyond, the rearmost point of the car.

APPENDIX ONE

SAFETY REQUIREMENTS

The provisions of article 253 of Appendix J of the FIA year book apply in full, however the Specific and the Technical Regulations for GT3 and GT(M) shall override article 253 where applicable.

FLAG SIGNALS

Due to the Guia Circuit's configuration, the following flag signals will be used throughout the meeting at Melco hairpin and the Line.

- Black** (motionless) With number in white on blackboard.
Signal for the vehicle bearing that number to stop at the pits on the same lap.
- Black & White divided diagonally** (motionless) With number on blackboard.
Warning of unsportsmanlike behavior.
- Black with Orange disc** (motionless) With number on blackboard.
Warning that vehicle has mechanical problem likely to cause danger. Must stop at the pits on same lap.
